




BE IT ENACTED BY THE QUORUM COURT OF MARION COUNTY, STATE OF ARKANSAS,

This ordinance will amend Ordinance 2020-28. The previous ordinance had some improper verbage.

An appropriation ordinance to move monies from the additional motor fuel tax fund (ACT 416 of 2019) into the 2020 operating road budget, to cover the cost of Marion County's portion of a State Aid Road Project to resurface HWY 101.


Transfer \$24,620.00 from Fund 2003 into Road Department Operating Budget Fund 2000, and appropriate as follows:



Be it enacted by the Quorum Court of Marion County, Arkansas; an Ordinance to be entitled:

An Ordinance to amend the 2020 budget, Ordinance 2019-86.

**Article 1:**

Whereas, the County Collector wishes to appropriate \$12,820.00 from the Automation Fund 3001.




