ORDINANCE 2020-

BE IT ENACTED BY THE QUORUM COURT OF MARION COUNTY, ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE ADDRESSING THE FINANCIAL ISSUES WITH COUNTY GENERAL AND ALL OPEN POSITIONS.

ARTICLE 1, WHEREAS, all open positions that are paid from County General will be deleted from Numbers and Compensation. And until further notice there will be no raises given in any department in Marion County and a freeze on any open positions until further notice.

ARTICLE 2, WHEREAS, THIS ORDINANCE IS CONSIDERED AN EMERGENCY ORDINANCE FOR THE HEALTH AND WELFARE OF THE PEOPLE OF MARION COUNTY ARKANSAS AND GOES INTO EFFECT IMMEDIATELY.

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF MARION, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL OPERATING BUDGET FOR THE CALENDAR YEAR 2020 FOR MARION COUNTY, ARKANSAS.

ARTICLE 1. WHEREAS, there is a need to appropriate money in fund 3020 Marion County 911 in the amount of \$47,220.11 above the current budgeted amount; therefore, raise anticipated revenue \$47,220.11 and appropriate as follows:

ORDINANCE 2020-

BE IT ENACTED BY THE QUORUM COURT OF MARION COUNTY, ARKANSAS AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE ADDRESSING THE 10% CUTS ACROSS THE BOARD IN COUNTY GENERAL.

WHEREAS, On \_\_\_\_\_, 2020, the Marion County Quorum Court enacted an ordinance directing a 10% cut to Marion County \_\_\_\_\_ (County General)

WHEREAS, Certain Marion County Elected officials worked to help budget issues by moving certain employees to lawfully authorized special funds within their offices and

WHEREAS, certain accounting measures are needed to properly note the changes to the Marion County budget, now therefore, be it enacted:

ARTICLE 1: When an employee's pay is moved from County General to a special fund this shall be reflected in the Adjusted Budget line item from Personal Services. (taken out of). Also, the Personal Services shall reflect what the employee's actual salary is and not the max salary. (This includes APERS and FICA)

ARTICLE 2; All ordinances not in conflict with this ordinance shall remain in full force and effect.

ARTICLE 3: This ordinance is considered an emergency ordinance for the health and welfare of the citizens of Marion County, Arkansas and is effectively immediately.
