RESOLUTION OF MARION COUNTY QUORUM COURT

Resolution # 2019- 6

Be it resolved by the Quorum Court of Marion County, State of Arkansas a resolution entitled Marion County Road 6064.

A Resolution authorizing the County Judge of Marion County to apply for a grant on behalf of the Marion County Road Department.

Whereas, the Marion County Quorum Court has determined that the Road Department of Marion County meets eligibility requirements necessary to apply for a grant under the Eastern Federal Lands Access Program Grant; and

Whereas, the Road Department has presented plans to add a slab, chip and seal, and lay base to County Road MC 6064; and


Whereas, the Quorum Court of Marion recognizes the need for the project, concurs its importance, and supports the Road Department in its efforts to proceed with the same; and


Whereas, the Marion County Road Department has furnished proof that they have raised approximately \$53,503.20 through community cash and/or in-kind donations to be applied to the project as a local match;

Therefore, be it resolved, that the Road Department of Marion is hereby authorized to submit an application of formal request to the Eastern Federal Lands Access Program for purposes of securing grant funds in the amount of \$214,012.80 to aid and assist the Road Department in executing the proposed project described herein and that the County Judge or

Treasurer of Marion County is further authorized to administer the grant funds for the same project.
